## Twice Loved Boutique Consignment Agreement

1. Consignor agrees to consign items to Twice Loved Boutique at 11 Monroe Highway, Brooks, ME. for a period of 60 calendar days, starting \_\_\_\_\_. Consignor warrants they possess complete and clear title to all merchandise consigned and will NOT hold Twice Loved Boutique responsible for any claim from another party to consigned merchandise. Consignor is responsible for the pick up of any unsold consignment items within Ten (10) days of the consignment period ending. Consignor MUST give at least twenty-four (24) hours notice before picking up. All unsold items NOT picked up within Ten (10) calendar days will, without further notice, automatically become property of Twice Loved Boutique.

2. Prices & Fees:

Initial pricing of merchandise and future markdowns will be determined by Twice Loved Boutique. Consignor price suggestions will be considered, but items will be priced to sell based on availability, supply and demand. Consignment items are susceptible to store-wide sales and promotions. Twice Loved Boutique reserves the right to decline merchandise at its own discretion, to be returned to owner or disposed of either immediately or with unsold items at the end of consignment period.

Fifty percent (50%) of the selling price of each item shall be retained by Twice Loved boutique. Fifty percent (50%) will be paid to the listed consignor only. Consignor is responsible for collecting any money owed for goods sold at the end of consignment period, via Cash (under \$25) or Check (\$25 or more). Consignor will be required to present their consignor number and photo identification to collect unsold items and/or any money owed.

3. Liability: While every reasonable effort will be made by Twice Loved Boutique to safeguard consigned items at 11 Monroe Highway, Brooks, ME, Twice Loved Boutique assumes NO responsibility for the loss, damage to, or destruction of any consigned item(s) by fire, theft, accident or any other cause.
